Prior to joining the U.S. Attorney’s Office, Mr. Washington held various positions at Conoco Inc. from 1982–1996, including serving as Chief Counsel for Conoco’s Gulf of Mexico Division until 1996. He was in the private practice of law from 1996–2001. Mr. Washington received his juris doctor degree from the South Texas College of Law in 1989, and his Bachelor of Science in Mechanical Engineering from the United States Military Academy at West Point in 1977.
