The Health Information Technology for Economic and Clinical Health Act (HITECH Act) contained sweeping changes to HIPAA's security and privacy requirements, including new security breach notification standards for HIPAA-covered entities, increased criminal and civil penalties for noncompliance, and the expansion of HIPAA's privacy and security requirements to business associates. These changes directly impact both healthcare providers and their business associates. In this webinar, Lynn M.
