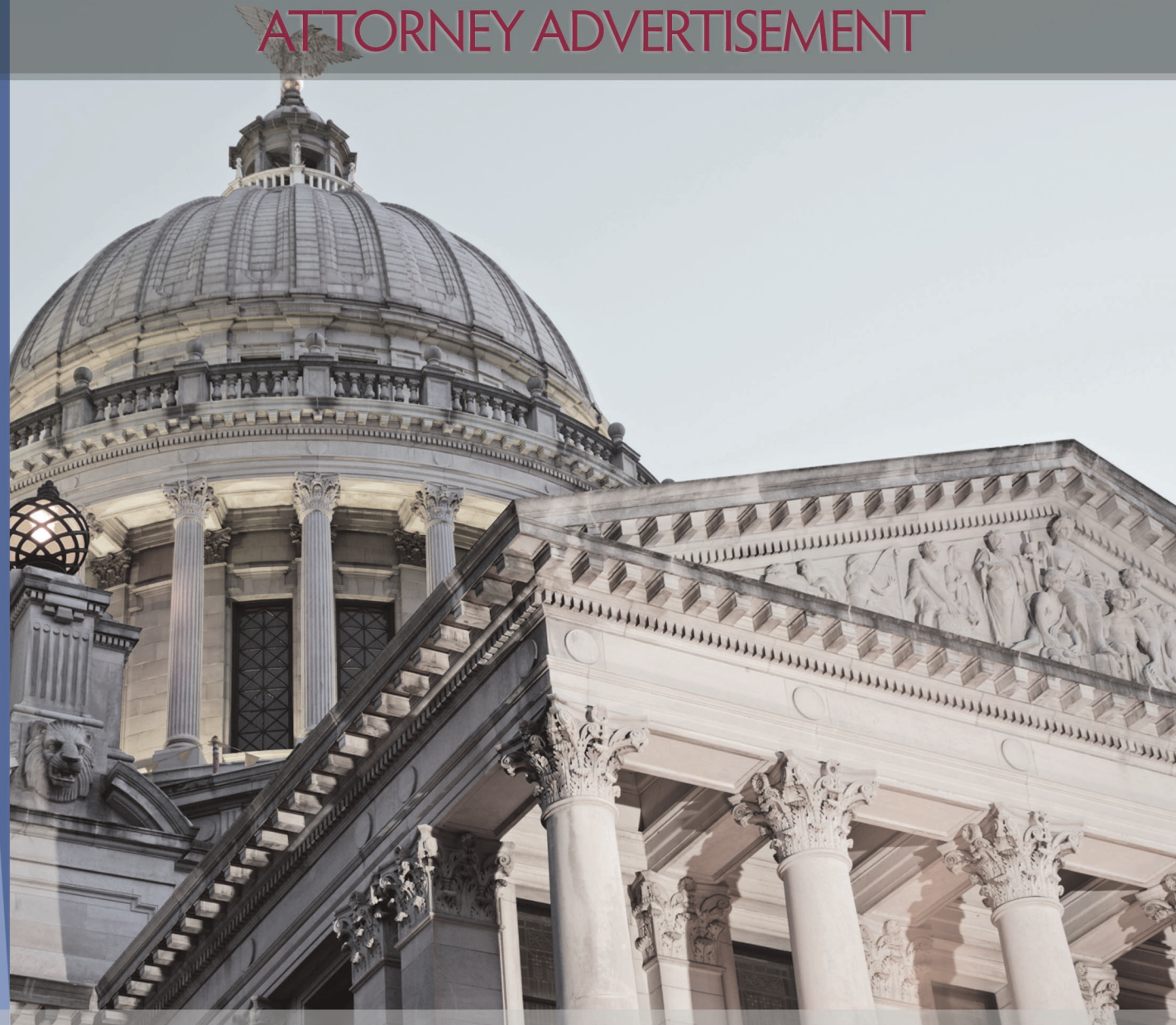

So in our concluding segment, we'll offer guidance on how to craft an AAP to meet the new challenges posed by today's OFCCP, including how to build your AAPs by "establishment" and how going narrow is better and the importance of compensation in job group formation. We'll also discuss strategies for dealing with OFCCP's Internet applicant rule, how to cast a wide enough net to gather in a diverse applicant pool without overburdening your recordkeeping, testing for adverse impact and statistical significance in applicant flow, selection rates, and goal setting, and what to do to comply with the new veterans outreach initiative.
