

COURT OPERATIONS UPDATE: October 7, 2005

The following is a listing of the latest available information regarding the operations of and proceedings before Louisiana and Mississippi courts affected by Hurricanes Katrina and Rita.

SUSPENSION OF LEGAL DEADLINES IN LOUISIANA

• On September 23, 2005, Louisiana Governor Kathleen Blanco issued Executive Order KBB 2005-48, which amended Executive Order KBB 2005-32, which was issued September 6, 2005, as follows:

All deadlines in legal proceedings, including liberative prescriptive and peremptive periods in all courts, administrative agencies, and boards are hereby suspended until at least October 25, 2005, including, but not limited to, non-constitutionally mandated deadlines in criminal proceedings and any such deadlines set for in the following:

- 1. Louisiana Civil Code;
- 2. Louisiana Code of Civil Procedure;
- 3. R.S. Title 9, Civil Code Ancillaries;
- 4. La. R.S. Title 13, Courts and Judicial Procedure;
- 5. La. R.S. Title 23, Chapter 10, Workers Compensation;
- 6. La. R.S. Title 40, Chapter 5 Part XXI-A, Malpractice Liability for State Services; and
- 7. La. R.S. Title 40, Chapter 5, Part XXIII, Medical Malpractice."

The suspension of laws . . . shall apply statewide and in all matters, except to the extent that the suspension of deadlines in legal proceedings may hereafter be shortened or lifted, in whole or in part, by an order issued by the Louisiana Supreme Court acting in accordance with the power vested pursuant to Article V of the Constitution.

- On October 3, 2005, Chief Justice Pascal Calogero, on behalf of the Louisiana Supreme Court, signed a Resolution establishing a temporary procedure to facilitate the shortening or lifting of the suspension of legal deadlines in appropriate cases. The Resolution is effective upon signing and through October 25, 2005, and is subject to an automatic extension in the event the Governor issues any future Executive Order(s) extending the time period for the suspension of deadlines applicable to legal proceedings. It provides as follows:
 - 1. The judge(s) of any Louisiana court, trial or appellate, may lift or shorten the suspension periods outlined in Executive Orders KBB 2005-32 and KBB 2005-48 in the event a joint motion is filed in the pending proceeding by all parties (represented or unrepresented) in the litigation, in which all parties certify that no attorney or party to the proceeding has been adversely impacted by Hurricanes Rita or Katrina.

- 2. The judge(s) of any Louisiana court, trial or appellate, may lift or shorten the suspension periods outlined in the aforementioned Executive Orders in the event a joint motion is filed in the pending proceeding by all parties (represented or unrepresented) in the litigation, in which all parties certify that, notwithstanding the fact that a party or attorney has been adversely impacted by either Hurricane Katrina or Rita, the impacted party or parties are nonetheless in agreement that the suspension periods should be lifted or shortened and the legal proceeding should be allowed to proceed. In such cases, affidavits shall be appended to the joint motion by all adversely impacted parties or attorneys. The affiants should attest to their willingness to have the suspension of legal deadlines lifted or shortened.
- 3. Any party who is unaffected by Hurricanes Katrina or Rita, or any party that, although adversely impacted by Hurricanes Katrina or Rita, nonetheless wishes to shorten or lift the suspension of legal deadlines, may file a Rule to Show Cause, or similar Motion in criminal proceedings, asking the Court to lift or shorten the suspension of legal deadlines. Prior to filing such a Rule or Motion, the moving party shall discuss with all other parties the reasons the party or parties have for objecting to a shortening or lifting of the legal deadlines, and shall include in the Rule or Motion an explanation of the reasons any party has for objecting to the lifting or shortening of the legal deadlines.
 - a. The Rule to Show Cause or Motion shall be served on all parties to the proceeding.
 - b. Within three (3) days of service of the Rule or Motion, any party may file a written objection.
 - c. At any time after the three day period for objecting, the presiding judge or judges may render a decision on the Rule or Motion.
 - d. In assessing the Rule to Show Cause or Motion, the presiding judge or judges shall apply a rebuttable presumption that the Rule or Motion should be denied in any case in which an objecting party or attorney maintained his/her domicile or principal place of business in a Parish that was under an evacuation order for at lest two days.
 - e. Absent extraordinary circumstances, the Rule to Show Cause or Motion shall be denied in any case in which an objecting party or attorney offers proof that either the objecting party or the party's attorney maintains his/her domicile or principal place of business in a Parish that was under an evacuation order at the time of the filing of the Rule or Motion. Absent extraordinary circumstances, the Rule or Motion shall also be denied in any case in which an attorney or party offers proof that he/she was displaced from his/her domicile or principal place of business for more than seven (7) days because of an evacuation order, or because damage to the attorney or party to be displaced from his/her domicile or principal place of business caused the attorney or party to be displaced from his/her domicile or principal place of business for more than seven (7) days.
- 4. No party or attorney for any party shall have cause to object to a shortening or lifting of the suspension of legal deadlines pursuant to this temporary rule if neither the party, nor the party's attorney, has been adversely impacted by Hurricanes Katrina or Rita.
- 5. No Order lifting or shortening the suspension of legal deadlines shall serve to lift the suspension of liberative prescriptive periods or peremptive periods.

- 6. For purposes of this temporary rule, the term "adversely impacted" means the ability of a party or a party's attorney to proceed with the legal proceeding has been substantially impaired by Hurricane Katrina or Rita.
- 7. Writs from adverse trial court decisions on any Rule to Show Cause or Motion shall be taken in accordance with law.

LOUISIANA FEDERAL COURTS

U.S. COURT OF APPEALS FOR THE FIFTH CIRCUIT

- The U.S. Court of Appeals for the Fifth Circuit opened for new filings on September 21, 2005. The Court had been closed since August 26, 2005.

- The Court entered an Order on September 12, 2005 that provides as follows:

For the purposes of serving and filing papers, Tuesday, October 11, 2005 is deemed the first regular business day following August 26, 2005. This treatment does not impair either the effectiveness of service of papers made during the period August 27 through October 10, 2005, or the effectiveness of the filing of papers accepted for filing during that period by the Clerk of the Court at the substitute site of the Court; however, as to any paper filed or served during that period, the deadline for responding, whether stated as a date certain or as a specified interval following service or filing, shall be extended to the later of October 25, 2005, or the first business day following the expiration of 15 days after the otherwise applicable deadline. The Clerk of the Court is instructed to promptly deny as moot any motion for extension that is obviated by the effect of the Order. Any motion for an extension beyond the times provided by the Order should be filed promptly. Parties are encouraged to confer in order that the motion may be presented as agreed. Mandates will be issued not sooner than otherwise provided by law or applicable rule or soon thereafter as the above-referenced conditions reasonably permit.

• The Court has posted oral argument schedules for September and October to be heard in Houston, Austin and Plano on its website.

U.S. DISTRICT COURT FOR THE EASTERN DISTRICT OF LOUISIANA

- In the aftermath of Hurricane Katrina, the Court's website <u>www.laed.uscourts.gov</u> will be the primary means of communicating with the bar and the public.
- The New Orleans offices of the United States District Court for the Eastern District of Louisiana are closed until further notice. By order of Chief Judge Helen G. Berrigan, all deadlines and

delays in matters pending before this court are suspended until ordered otherwise. In addition, all prescriptive periods and other time-sensitive deadlines for new litigation are likewise suspended until further notice.

• The Court has established temporary offices in Lafayette, Baton Rouge and Houma, Louisiana. If possible, all filings should be made in person or by mail to the temporary Lafayette office which is located at the following address:

- Filings will also be accepted in Baton Rouge at the Middle District of Louisiana's Clerk's Office and at the Eastern District Courthouse in Houma, Louisiana.
- Filings by fax (with the exception of new complaints) have also been approved until further notice. The fax number is 337-262-6776.
- If filing by fax, DO NOT mail/deliver a hard copy to the Clerk's Office.
- All displaced attorneys are asked to provide the Court with a change of address and telephone number and a current e-mail address as soon as possible.
- The Court is asking attorneys who have trials scheduled in the Eastern District of Louisiana from now until the end of the year to file a motion with the court in the Lafayette Division of the Western District 800 Lafayette Street, Suite 2100, Lafayette Louisiana 70501 either in person or by mail advising if they want to keep their trial date as scheduled or if they need a continuance of their trial date, and how long a continuance they need.
- Once the court system is operational in the tri-locations, and regular motion practice resumes, oral argument should be requested only when absolutely necessary and may be conducted by conference call rather than in person because of limited courtroom availability.

- By order of Chief Judge Jerry A. Brown, all filing deadlines imposed by the Federal Bankruptcy Rules, the Local Bankruptcy Rules, and orders of this court are extended until September 26, 2005. Trial and hearing dates will be rescheduled at a later date.
- All hearings, trials, motion days, and meetings of creditors set through the end of September 2005 are CANCELLED. Section B matters, however, may be rescheduled with the consent of all parties as per the attached dates.

U.S. DISTRICT COURT FOR THE WESTERN DISTRICT OF LOUISIANA

• Statement of Alexandria, Monroe, and Shreveport Divisions on Cases Affected by Hurricane Katrina –

Attorneys who are in need of extensions, relief from existing deadlines, or other accommodations because of Hurricane Katrina are asked to contact chambers of the judge to whom the case is assigned, either in writing or by telephone. All judges are willing to work with attorneys on fashioning an appropriate solution in each case. Counsel who are able to communicate with chambers in cases in which opposing counsel have difficulties are asked to take the lead in this effort.

- In the Lafayette Division, all court proceedings between Monday, September 26 and Wednesday, September 28th were cancelled, to be rescheduled at a later date. The Lafayette Division Clerk's office is open for regular business.
- The Lake Charles Division Courthouse is CLOSED until further notice. By Order of Chief Judge Richard Haik and Judge Patricia Minaldi, all deadlines in Criminal and Civil cases in the Lake Charles Division are suspended. All court proceedings previously set are CONTINUED WITHOUT DATE.
- The Alexandria Division Courthouse is now OPEN. All Court proceedings set in the Alexandria Division for Monday, Sept. 26 through Wednesday, Sept. 28th were cancelled, to be rescheduled at a later date.
- Judge Tucker L. Melancon issued a memo dated September 9, 2005 to attorneys of record in cases over which Judge Melancon presides, stating:

"It is my intention to ease, to the extent possible, the unprecedented suffering and havoc caused by Hurricane Katrina and its aftermath. As an attorney of record, I would appreciate you advising me by letter directed to chambers at 800 Lafayette Street, Suite 4700, Lafayette, Louisiana 70501, if, in your view, any of your cases over which I preside involve lawyers and/or parties who have been or *may have been* affected by Hurricane Katrina and/or its aftermath. Please set out the case name and number as well as the name address and telephone numbers of all attorneys of record. I would appreciate it if you would respond to this letter as soon as possible, preferably no later than September 20, 2005 if at all possible."

"In the interim, I assure you that I will grant all necessary and appropriate relief to existing deadlines and trial dates to affected lawyers and parties. No affected lawyer nor lawyer's affected client should make litigation pending before me a priority at this time."

• Judge Donald E. Walter issued the following notice:

In cases assigned to Judge Walter, all deadlines are extended until October 6 in cases involving attorneys affected by Hurricane Katrina. Any suspension of deadlines in other cases will need a motion and will be dealt with on an individual basis as is the normal practice.

• Judge Patricia Minaldi issued the following notice:

All deadlines and fixings in civil cases assigned to Judge Minaldi which fall in the month of October, 2005, have been suspended. Any case in which all parties agree to move forward should be brought to Judge Minaldi's attention for placement on the calendar. U.S. BANKRUPTCY COURT FOR THE WESTERN DISTRICT OF LOUISIANA

- The Alexandria Divisional Office was closed September 26, 2005, beginning at noon, and on September 27, 2005. All court (hearings, conferences and 341's) will be rescheduled.
- An Order issued with respect to cases assigned to the Lake Charles Divisions provides that in such cases, whether presently pending or filed during the effective period of the Order, which is September 23, 2005 until October 31, 2005, all court-imposed deadlines and delays are suspended; all statutory time limits (i) for filing contested matters and adversary proceedings, and (ii) imposing filing requirements on debtors are suspended; in those cases where motions relief from stay are pending, the automatic stay shall remain in full force and effect. Notwithstanding the above, and on good cause shown, the court may entertain motions seeking relief from the foregoing suspensions. In addition, all court hearings scheduled on Thursday, September 29, 2005 were continued and refixed to October 20, 2005. Hearing will be held in the Bankruptcy Courtroom, First Floor, 214 Jefferson Street, Lafayette, Louisiana. Chapter 13 matters will be heard at 10:30 a.m. and Chapter 7 and 11 matters will be heard at 2:30 p.m. The October 20, 2005 session of court will be held in the Bankruptcy Courtroom, First Floor, 214 Jefferson Street, Lafayette, Louisiana. Chapter 7 and 11 matters will be heard at 2:00 p.m.
- An Order issued with respect to cases assigned to the Lafayette and Opelousas Divisions provides that in such cases, whether presently pending or filed during the effective period of the Order, which is September 23, 2005 until October 31, 2005, all court-imposed deadlines and delays are suspended; all statutory time limits (i) for filing contested matters and adversary proceedings, and (ii) imposing filing requirements on debtors are suspended; in those cases where motions relief from stay are pending, the automatic stay shall remain in full force and effect. Notwithstanding the above, and on good cause shown, the court may entertain motions seeking relief from the foregoing suspensions.

COMMUNICATIONS CENTER FOR FEDERAL COURTS

- Louisiana's federal courts, in conjunction with the state and federal bar associations, have authorized a Communications Center to assist lawyers displaced by Hurricane Katrina in reestablishing contact with the federal courts and their fellow lawyers. On September 13, 2005 Chief Judge Richard T. Haik, on behalf of the Judges of the United States District Court for the Western District of Louisiana, issued an order appointing a Special Master for a four month period "to assist attorneys with communication and coordination with the court." In issuing his order, Judge Haik recognized that Hurricane Katrina has caused "disruption of the legal system" giving rise to the need for assistance in locating lawyers and keeping them abreast of the status of the cases that they are handling in Louisiana's federal courts.

- The Center offers the following services to displaced lawyers:
 - For those attorneys without permanent or stable contact information, the Center will facilitate the creation of an e-mail address which will serve as the lawyer's address for all electronic communications issued by the courts concerning his or her federal cases;

- By notifying the Communications Center of his/her new or temporary contact information, an attorney may be assured that his/her information will be forwarded to all the federal courts in Louisiana, and that other, non-displaced lawyers in his/her cases will have access to that information as well;
- If an attorney's file has been destroyed or damaged, the Communications Center will assist the attorney in having PACER print charges temporarily waived. In this manner, an attorney may obtain copies of documents filed into the court records free of charge;
- The Special Master may assist in the reconstruction of any lost and/or destroyed files in cases where counsel has been appointed pursuant to 18 U.S.C. 3006A. Further, the Special Master may make efforts to collect information so as to facilitate contact between criminal defendants, their attorneys and the Federal Public Defenders Office;
- Due to the Hurricane, the judges and court staff for the Eastern District courts located in New Orleans are in the process of relocating. The Center will provide updates regarding contact information for Eastern District judges as it becomes available;
- The Center will supply upon request by a displaced lawyer a complete listing of those cases the lawyer has pending before the Western District, including a listing of all notices and orders filed in those cases since the Hurricane. As soon as the Eastern and Middle Districts offer the same capability, similar lists will be offered for those districts as well;
- For those displaced lawyers whose cases require immediate attention, the Center will facilitate contacts with the appropriate displaced judge, magistrate or other court personnel;
- The Center will provide a central location by which to access relevant general orders or notices issued by the courts, as well as pertinent legislation, announcements or developments that may bear upon the reconstruction of our legal system.

LOUISIANA STATE COURTS

LOUISIANA SUPREME COURT

- Closed from August 29, 2005 through October 25, 2005. [Note that this is an extension of the previously published September 9 and October 1 dates.]
- In closure orders issues in early September, the Court ordered that filings due during the period of closure will be deemed timely if filed within 5 days of notice of resumption of "normal Court operations." While this language has not been repeated in more recent orders, it does not appear to have been expressly rescinded in any order.
- Oral arguments scheduled for September 5-8, 2005 were postponed.
- Louisiana Supreme Court Chief Justice Pascal F. Calogero, Jr. announced that the Supreme Court will reopen at its French Quarter location as soon as practical. According to Chief Justice Calogero, the Courthouse at 400 Royal Street in New Orleans sustained minimal damage from Hurricanes Katrina and Rita. While the courthouse, as with most French Quarter property, did

not receive flood waters, the basement in the building did take on some water, and some damage was caused by a loss of power to the pumps in the basement and the rising water table beneath the building. That minor amount of water has been pumped out of the basement and some records have been removed for preservation. Cleaning and examination of mechanical and electrical equipment is being overseen by the State's Division of Administration and should be completed in the near future. Chief Justice Calogero stated, "Our employees will return to the courthouse and we will be open for business as soon as we have been assured that it is safe to do so. I look forward to calling Court to order once again at 400 Royal Street."

- While the Supreme Court has suspended the usual processing of filings, as well as consideration of writ applications and entertaining oral arguments, through October 25, 2005, the Supreme Court's Justices, Judicial Administrator, Clerk of Court, and supervisory personnel have been working since Hurricane Katrina at its temporary location at the First Circuit Court of Appeal in Baton Rouge. The Court has been handling administrative matters and offering assistance to local courts affected by Hurricanes Katrina and Rita in their efforts to return to normal operations.
- For attorneys who wish to register a change of address, the Supreme Court of Louisiana has authorized the Louisiana State Bar Association (LSBA) to receive change of address information on its web site, located at www.lsba.org.
- An unsigned memorandum to all Louisiana judges appears on the Supreme Court's website asking judges to "temporarily waive the dress code normally required in your court" and exercise patience with those who appear excusably late for court." In addition, judges are asked to give "compassionate consideration to requests for continuances in those cases where lawyers have lost contact with clients, witnesses or staff or have files that have been destroyed or are unavailable."

LOUISIANA FIRST CIRCUIT COURT OF APPEAL

The Clerk's Office has issued the following "Filing Guidelines for 'Affected Cases' due to Hurricane Katrina":

General

- The guidelines below are being used by the First Circuit Court of Appeal Clerk's Office and <u>only</u> relate to the documents due that are marked timely or late <u>upon filing</u> when there is no immediate interaction with the Court at that time.
- Any rehearing applications relate to dismissals prior to consideration on the merits by the Court. There are no rehearing deadlines on cases that the Court decided in August that fall during the week of August 27th through Sept 2nd.
- Also, note that the Clerk's Office does not determine whether a writ application is filed timely or late. All writ applications filed are routed to a Court panel. The reference in the guidelines below to the writ application extension concerns only the collection of the fee.
- "Affected case" means a case involving a court that is in an area that is not functional or involving an attorney in a non-functional area, such as Orleans, St. Tammany, Tangipahoa, etc. For the most part, this will be a "good judgment" call for the Clerk's Office. All actions taken by the Clerk's Office are subject to review by the Court if there is not a "meeting of the minds" in regard to the Clerk's Office's designations.

Dates/Fees for Filing Documents

- Monday and Tuesday, August 29 and 30, 2005 are "holidays" for filing purposes.
- <u>All documents</u>, except rehearing applications, answers or other document with a due date established by law, due on any day from August 27, 2005 through September 5, 2005 will be considered timely if filed on or before Tuesday, September 6, 2005. If an extension is presented for one of these document due, it will be processed; however, a request for an extension does not have to be filed provided the document due is filed on or before September 6, 2005. Fees for extensions of briefing deadlines will be suspended from August 27, 2005, through September 5, 2005 (in the event the filing cannot be made by September 6, 2005).
- The Clerk's Office will review all recently lodged cases for due dates for briefs on cases involving "affected cases" and will automatically suspend briefing until further notice. The list of "affected cases" with suspended briefing will be posted to the web-site LA-FCCA.ORG. This list will be reviewed periodically and updated with briefing resumed when the case is no longer on the "affected case" list. (To reduce the potential number of extensions, notices of abandonment, rehearing applications, etc. for those who may be non-functional for several months).
- After September 6, 2005, for those not on the list of "affected cases", each situation will be handled on a "case-by-case" basis to determine timeliness for the filing. A fee for an extension of briefing deadlines may be suspended on a case-by-case basis for a newly-discovered "affected case."
- Fees for extensions of due dates for writ applications will be suspended on a case-by-case basis for "affected cases."
- All rehearing applications, answers or other document with a statutory deadline will be filed according to regular rules. If "late", the pleading will be marked as such and a "show cause" issued so the Court can determine whether or not the pleading can be considered in light of Hurricane Katrina circumstances.

• The court asks attorneys to call the Clerk's Office at 225-382-3000 with any questions about the docket for September, or, if your case is scheduled for oral argument and you do not plan to be here. The Clerk's Office will assist you with any message or request that you wish to present to the Court in regard to the scheduled arguments.
