- Department of Labor - Contains information on DOL agencies and programs. To access FMLA forms, choose the Employment Standards Administration, then, go to the Wage and Hour Division. The FMLA forms will be on the right hand side of the page.
- Louisiana Department of Labor - Includes the Louisiana Occupational Information System.

- Equal Employment Opportunity Commission - See what's new with the EEOC.
- Immigration and Naturalization - Here in one place is a complete set of information to introduce you to the Immigration and Naturalization Service.
- National Labor Relations Board - Conducts secret-ballot elections to determine whether employees want union representation and investigates and provides remedies for unfair labor practices by employers and unions.
- OSHA - Workplace Violence Guide - OSHA has developed guidelines and recommendations to reduce worker exposures to this hazard. This site contains aids for recognition and control of workplace violence, training links, and other resources.
- Office of Federal Contract Compliance - The OFCCP is the government agency responsible for overseeing affirmative action plans of employers and their subcontractors working on government sponsored projects.

- Code of Federal Regulations - The CFR online is a joint project authorized by the publisher, the National Archives and Records Administration's Office of the Federal Register, and the Government Printing Office (GPO) to provide the public with enhanced access to Government information.
