Douglas Whiting is a special counsel in Jones Walker's Real Estate Practice Group, and practices from the firm's Woodlands office.

Mr. Whiting has negotiated and closed more than \$15 billion of transactions on six continents involving electric power, oil and gas services, refinery, and other energy-related facilities, as well as the development of large-scale precious metals mining projects. His focus has been on areas as diverse as acquisitions/divestitures, engineering/procurement/construction, project development, operations and maintenance agreements, real estate development, and master services/supply agreements.

He has served as the general counsel for a publicly traded group of oilfield services companies, assistant general counsel for utility-affiliated domestic and international power plant developers and operators, and as U.S. divisional counsel for a European-based power plant developer and industrial process/refinery/power plant equipment supplier. Among other activities, Mr. Whiting was a part of a 12-person team that formed, started up, financed, and expanded a company that became one of the largest independent power producers in the world. These experiences allowed him to work out of offices throughout Southern California, Houston, in the Washington, D.C. area, and in Helsinki, London, and Singapore. He is also capable of conducting business in German, having lived in Southern Germany for two years, where his volunteer service activities for a large international religious organization were conducted in German more than 80 percent of the time.

As an in-house attorney, Mr. Whiting was responsible for international compliance training as well as legal support for a variety of functions, including law department management, governmental affairs and lobbying, human resources support, securities, strategic planning, intellectual property registration and management, technology licensing, and litigation

management. He has managed the corporate secretary functions for more than 400 companies, including companies located in foreign countries. Much of his work currently focuses on supporting a large international engineering and construction company that is designing and constructing refineries or refinery retrofits, LNG facilities, and related systems in the Americas, Eastern Europe, Asia, and Latin America.

Mr. Whiting has served as the chair of the International Energy Committee of the Association of Corporate Counsel (formerly known as the American Corporate Counsel Association), where he headed a committee of approximately 750 attorneys located throughout North America, Europe, Latin America, and the Asia-Pacific regions. He has also served as a board member of ACC's Houston Chapter. He is a founding board member and former president of The Woodlands, Texas Bar Association and has served as the Houston Chapter President of the J. Reuben Clark Law Society, an international legal organization that advocates and encourages attorneys to promote fairness and virtue founded upon the rule of law through the exercise of high moral and ethical standards in their legal practices and through public service. He has served as a board member on regional and national trade groups such as the Electric Power Supply Association and its predecessor groups, the Electric Generation Association and the National Independent Energy Producers. He has also served as a company representative to the National Mining Association.
