8:45-9:30 AM:

Recent Enforcement Trends in Health Care

Government authorities are sharply increasing civil and criminal enforcement in the health care arena. Government agents, prosecutors, provider association executives, and defense attorneys will discuss priorities for federal and state investigations.

9:30-10:00 AM:

HIPAA Compliance

The Health Information Technology for Economic and Clinical Health Act contained sweeping changes. These changes directly impact both health care providers and their business associates. This panel will include a Chief Compliance Officer of a large health system, as well as a lawyer with experience in this area who will provide an overview of the changes to HIPAA and will offer practical guidance for complying with these new requirements.

10:15-10:45 AM:

Recent Changes in Fraud and Abuse Enforcement Legislation

Both the recently enacted health care reform legislation and the Fraud Enforcement and Recovery Act of 2009 contain significant fraud and abuse enforcement provisions. This presentation will discuss some of the key changes, including amendments to the Anti-Kickback Statute, the Stark Law, the False Claims Act and the Civil Monetary Penalties Act.

10:45-11:15 AM:

False Claims Act and Internal Investigations

This session will provide an overview of the elements of liability under the False Claims Act and examine the Act's *qui tam* provisions, under which private citizens may sue defendants on the government's behalf. Presenters will also discuss key considerations for health care providers conducting internal investigations of alleged False Claims Act violations.

11:15-11:45 AM:

Real Life Example

Presenters will discuss the civil and criminal implications for a health care provider if it billed Medicare and Medicaid for services that were not covered by these programs. The panel includes government, defense, and investigating agents' perspectives.

Health Care Reform Legislation: Quality Initiatives, Program Integrity, and Payment Provisions

The health care reform legislation provides changes in, among other areas, quality initiatives, program integrity and payment provisions. This presentation will spend time covering these three areas, including a brief discussion on accountable care organizations and the medical home model.

Billing Compliance

In 2010, there have been a number of government settlements and initiatives concerning billing practices. The panel will include the Chief Compliance Officer from a large health system, as well as a lawyer and consultant who routinely handle evaluation and resolution of significant compliance issues. Presenters will share experiences with government and contractor audits, address current and future regional and national approved issues for review, and provide recommendations for the preparation and management of audits.
