Mr. Lange is a past founder and CEO of Redundant Networks, Inc. and has worked for a variety of publicly traded technology start-up companies.

Richard Montgomery is Managing Director of Enhanced Capital Partners, a specialty investment firm headquartered in New York City. Based in New Orleans, Mr. Montgomery co-heads the firm's Federal and State New Markets Tax Credit business lines and manages Enhanced Community Development, a community development entity that has received an aggregate of \$233 million of Federal and State New Markets Tax Credit allocation, including \$27 million of Alabama New Markets Tax Credit allocation. In addition, Mr. Montgomery manages the firm's other tax credit businesses, which includes monetization of Historic Rehabilitation and other Federal and State tax credits.

Will Shurtleff is the Tax Credit Administrator for Trustmark National Bank and Executive Vice President and Chief Operating Officer of Southern Community Capital, a community development entity and wholly owned subsidiary of the bank.
