Experience Highlights

Represent a multibillion dollar petrochemical facility. The industrial complex will produce polyethylene, polypropylene, polymer and ethylene glycol once it is fully constructed and operational. We represent the owner in all of its contract drafting and negotiations with the various EPC contractors, which include some of the world's largest, most sophisticated entities. This high profile project is in the early stages of its construction.

Represent a government contractor in dispute with the Army Corps of Engineers relating to improvements to a major interstate in Los Angeles. The Corps terminated the contract for default asserting that our client could not complete the project by the contractually-required completion date. We are appealing the termination with the Armed Services Board of Contract Appeals challenging the wrongful termination and seeking compensable time extensions.

Represent the general contractor constructing a cogeneration facility for a large petrochemical plant. We have made claims for delay totaling more than \$21 million in addition to nearly \$8 million in an unpaid contract balance, and we are also defending against a \$26 million counterclaim by the owner. The matter is further complicated by the downstream claims against the client's general contractor by subcontractors ranging from \$5 million to \$7 million related to allegations of delay and productivity losses.

Represent an owner of a new \$9.2 billion, state of the art, renewable energy complex. The facility will produce green hydrogen, renewable diesel, sustainable aviation fuels, as well as bio-plastic feedstocks, which will be constructed in Louisiana and also includes carbon capture and sequestration. The project is in its early stages, and we will review and negotiate an engineer procure and construct (EPC) contract, along with other matters as they arise.

Advised a global corporation on the successful design, development, and construction of a state-of-the-art \$1 billion processing facility. We assisted a global owner in development and construction of its greenfield hot briquetted iron (HBI) facility in Corpus Christi, Texas. We assisted the project with developing, zoning, tax credit issues, drafting its EPC contracts, and real-time construction issues. When four significant disputes arose, we assisted the client in resolving two disputes and arbitrating two other disputes before the ICC.

Advised a shipyard company on billion-dollar expansion projects. We represented an international ship builder on issues and disputes arising in connection with several major contracts with the US Coast Guard and in the acquisition of over \$5 billion in surface assets that, taken together, has more than doubled the size of the shipyard and increased employment.

Represented Fortune 100 Global equipment manufacturer on a \$1.2 billion data center design build project for the US NSA. Substantial claims with the Government were resolved fairly early, but major disputes of over \$150 million remained amongst more than 10 contractors and suppliers that were ultimately resolved in mediation and arbitration.

Helped a global, US-based company build an overseas copper refining facility. We worked with our client's Japanese EPC contractor to negotiate contracts for the design and construction of a smelter in Indonesia to produce pure copper from copper concentrate, which included expanding and building a port, rail lines, electrical facility, and wastewater facility.

Represent a large Spanish contractor who is the design-build contractor on the I-77 corridor expansion project. This project includes the construction of toll roads, road expansion, and bridges on the major interstate surrounding Charlotte, North Carolina. We are counsel on a significant dispute with the major subcontractor concerning delays and inefficiencies with claims totaling over \$105 million USD in dispute and is pending before the America Arbitration Association (AAA).

Prosecuted multiple breach of contract disputes for a mechanical contractor. We represented our client in connection with its work for an international contractor on a \$1.9 billion greenfield fertilizer plant, obtaining a \$10.2 million ICC arbitration award and a \$62.5 million jury verdict on their behalf.

Represented one of North America's largest civil works contractors. We advised our client on a dispute in connection with a \$130 million highway and bridge design-build project in North Carolina. The matter involved complex design issues that resulted in millions of dollars in additional design and construction costs and delay.

Pursued and defended multiple claims on industrial project. We defended against contractor counterclaims for breach of contract, failure to grant extensions of time, and failure to approve change orders in multiple ICC arbitration proceedings.
