## Kern and Chess Successfully Defend AutoZone in Retaliation Case

New Orleans, La., and Miami, Fl., March 6, 2008— On February 26, 2008, Jones Walker Labor and Employment partners Tracy E. Kern and Laurie M. Chess received a defense verdict on behalf of AutoZone following a seven-day jury trial in a retaliation case in Wilmington, Delaware.

The plaintiff, an African American male, worked for AutoZone for two years as a part-time salesperson in its Smyrna, Delaware store. He filed an internal complaint of alleged racial bias against his store manager. Following the complaint, the plaintiff contends he was retaliated against by being denied a promotion to a full-time salesperson and/or parts sales manager position; disciplined unfairly for minor infractions; and given poor performance evaluations. The plaintiff further complained that he was subjected to a hostile work environment and constructively discharged as a result of his complaint. The employee sought to recover back pay, front pay, compensatory damages, attorney fees, and costs.

At trial, the plaintiff presented two former African American employees to support his position. AutoZone called its loss prevention manager, human resources manager, and district manager, all of whom testified the plaintiff was treated fairly. At the conclusion of the evidence, the Court granted AutoZone's motion to dismiss the plaintiff's claim of constructive discharge. The plaintiff's claims of hostile work environment and retaliation proceeded to the jury. After the jury deliberation, the jury entered a verdict in favor of AutoZone on all counts.
